## Description

In the last 30 days the County of El Paso has been under a COVID-19 Siege. On 10-27-20 the positivity rate 7 day rolling average was at 17.25% and as of November 7,2020 it is 25.11%. This is a nearly 554% increase in positivity rate since September. All of our employees have been working under tremendous circumstances- please see world news reports. As a result a PIA request that was submitted via email on October 26th was missed. We only became aware of it today 11-12-2020 and determined we are need of requesting this notice for past and future requests.
